NOTICE OF NON-AD VALOREM ASSESSMENTS FOR 2019

A combined tax and assessment bill will be mailed by the Tax Collector in November. **If you do not understand your assessment, or if you think an error has been made, please call the appropriate assessing body at the phone number listed below. You have the right to appear at a hearing or to file written objections with the local governing board within twenty days of this notice (twenty-five days for Solid Waste Landfill).**
